# MESSAGE FROM THE CHAIR



*The fiscal year ending March 31, 2006 witnessed significant changes which originated from the recommendations of the 2004 Perozzo Report on Legal Aid Manitoba.*

On August 10<sup>th</sup>, 2005, Bill 47 was proclaimed, and it significantly changed the way that LAM will function.

Section 2.1, of the Act proclaims that LAM is to serve the public interest by:

- (a) providing quality legal advice and representation to eligible low-income individuals;
- (b) administering the delivery of legal aid in a cost-effective and efficient manner; and
- (c) providing advice to the minister on legal aid generally and on specific legal needs of low income individuals.

The Board of Directors was replaced with a Management Council, and as set out in section 6, Council is to direct the business and affairs of LAM, and must:

- (a) oversee the financial management of LAM;
- (b) manage the resources of LAM efficiently;
- (c) establish operational and strategic policies for LAM; and
- (d) evaluate the quality and cost-effectiveness of the services provided by LAM and the delivery of legal aid in Manitoba.

Other significant changes were detailed by our Executive Director in the 2004/05 Legal Aid Annual Report.

Three members of the past Board of Directors were appointed to the new Management Council, five councillors are new. In addition to the regular matters, Council has set out to review existing structures to determine what changes are necessary in order to make LAM compliant with the new legislation.

Council established an Advisory Committee, approved its terms of reference, and appointed the members in accordance with the new legislation.

The previous Board of Directors, commissioned an operational review with Prairie Research Associates Inc. (“PRA”), and Council is expecting to receive the report with recommendations in May 2006. Council will give serious consideration to the report’s recommendations, and will direct operational changes which it deems beneficial to the organization.

LAM is funded by the Province of Manitoba, The Federal Government, the Manitoba Law Foundation and fee paying clients and their support is very much needed and appreciated. LAM is proud of the fact that Manitoba is considered to have the most extensive and robust coverage in Canada. Representation of the working poor through our expanded eligibility program, is an example.

LAM is continuously being asked to do more with less. Altogether, LAM has been able to meet most needs with no

increase in funding for infrastructure or support staff while additional resources are allocated to the Police and Public Prosecutions. It must be recognized that LAM requires the same proportional increases. A balanced approach is necessary.

LAM was pleased that the Manitoba Government in 2005 again increased the tariff paid to the private bar lawyers. Hopefully another increase will be approved in 2007, which will address the justified concerns of the private bar.

I wish to acknowledge the dedicated work of the past Board of Directors, and thank them for strongly advocating on behalf of LAM clients. I also thank our dedicated staff, volunteers, private bar and all Legal Aid stakeholders.

I look forward to an exciting and challenging future.

# MESSAGE FROM THE EXECUTIVE DIRECTOR



***R**eflecting over the past fiscal year, it is readily evident that Legal Aid Manitoba is entering into a new era.*

This new era is characterized by a series of changes, some imposed by myself and others by Management Council and the Province, to bring about improvements to LAM service

delivery. While some changes have been implemented out of necessity due to the steady decline in private bar participation, others have been imposed as a means to help LAM strive to evolve in its capacity to provide effective legal services to financially eligible people across the province while achieving a reasonable balance between cost and quality.

The new era of change is propelled primarily by the Province's decision to invoke legislative changes to our Act and regulations. Formally proclaimed in August 2005, changes to the LAM Act include:

- giving LAM more flexibility to appoint lawyers from either staff or the private bar while, where possible, considering an applicant's preference;
- enabling staff lawyers to conduct the defence in complex trials by dealing with conflict of interest guidelines;
- prohibiting eligibility for assistance to criminal organizations as entities and requiring mandatory

investigations into the assets of individual applicants charged with criminal organization offences;

- strengthening investigative and collection powers for legal aid; and
- streamlining and focusing legal aid governance and creating a new advisory committee.

As our chair, Mario Santos, outlined in his message, we have a new Management Council. On behalf of LAM, I would like to welcome new council members Tony Gauthier (Treasurer), Chris Martin, Luis Martinez, and Herbert Peters. I welcome back Marlene Campbell, Marietta Pellettieri, and Wendy Whitecloud who continue on from the previous Board. I would also like to thank the outgoing Board of Directors, Bill Armstrong, Rob Dewar, George Pelletier, Diane Dzydz, Dennis Troniak and Ivan Moose, for their direction and governance over their many years of service. Their commitment to our vision provided LAM with the ability to confidently address emerging challenges while striving to ensure that all Manitobans can access affordable legal assistance for their criminal and family matters.

Many events are reported in the year in review section. Other significant events that occurred during 2005/06 which impacted on LAM's organizational operations include:

- Pursuant to our amended conflict legislation, staff lawyers are now recognized as not being in conflict simply because they are advising or representing a person in a dispute who has been advised or represented by another LAM solicitor.

To adhere to these changes, all of our community law offices are now considered independent entities for conflict purposes. Conflict of Interest Policy and Procedures have also been implemented to govern the daily operations of our community law offices.

- Pursuant to the Legal Aid Lawyers' Association (LALA) 2003-2006 collective agreement, senior lawyers received pay increases in parity with the provincial crown attorneys. Additionally, in an arbitration decision, the BB2 category was redefined and is now attainable by senior staff lawyers having been called to the Bar for at least 10 years. Senior management has developed a formalized process to assess candidates seeking promotion from the BB1 to the BB2 category.
- The Province increased the tariff rate paid to the private bar for legal aid services in FY 05/06. The hourly rate for criminal and family law cases increased more than seven percent to \$57 per hour from \$53. The tariff for family matters also received a further five percent increase to recognize the time and effort put into such cases.

Priorities established for the coming fiscal year include developing and implementing an action plan arising from the operational review, developing a five year business and strategic plan, working with Management Council to invoke by-laws and governance processes, implementing and monitoring the impact of new conflict legislation, developing a complexity weighted caseload for staff lawyers as well as proceeding to find ways to provide services more efficiently and economically.

In 2005/2006 we provided legal services to over 80,000 clients with a mix of staff and private bar lawyers. Our service delivery remains exceptionally high despite fiscal exigencies, thriving demands for services, evolving case complexity and private bar attrition. LAM is very fortunate to have a dedicated and experienced staff willing to ensure accessible legal coverage for Manitobans with low incomes even under such difficult and stressful conditions.

I would like to thank staff for their ongoing support and commitment. The coming year will bring fundamental changes to the organization. I encourage staff to remain positive as LAM works towards renewing and strengthening its service delivery through changes in service coverage, procedures and protocols to include solid accountability processes that will prepare the organization to meet future challenges.

## Victories for the Public Interest Law Centre

The Public Interest Law Centre worked in partnership with Ms. Candace Everard of Pitblado LLP on a case dealing with rehabilitation expenses incurred by people injured in automobile accidents. In September 2005 the Public Interest Law Centre won in the Manitoba Court of Appeal, clarifying the law and paving the way for accident victims to claim reimbursement for a broad variety of rehabilitation expenses. This decision is particularly significant to accident victims left with intellectual disabilities or cognitive impairments who might otherwise have been excluded from the no-fault insurance scheme.

Late December brought another victory when the Province of Manitoba stayed charges against a number of First Nation resource users who had been charged with unauthorized use of Crown lands. Our clients had argued that their First Nation had unextinguished aboriginal title to the area in question. While the Province did not explicitly accept the existence of unextinguished aboriginal title, it conceded that the regulation in question is of no force and effect against First Nation people in the area.

The question of whether there continues to be unextinguished aboriginal title in Manitoba is being closely watched by the Province and First Nation communities as well as leading academics. A successful resolution of this case could open the doors of economic opportunity for a number of First Nations in this province and others.

The Public Interest Law Centre is continuing to work on this issue in cooperation with the firm of Myers, Weinberg LLP.

## Aboriginal Services

The Aboriginal Law Centre provides representation in both family cases and criminal cases as well as for individuals with other legal issues that are of particular concern to Aboriginal people or the Aboriginal community in general. Some of the other types of cases handled by the Centre involve issues of civil rights, human rights, band governance, treaty status, child protection services and the provision of other social services such as social allowances, health care and policing.

The Aboriginal Law Centre offers non-adversarial, consensus building and restorative approaches to the resolution of legal issues in a manner consistent with the values and traditions of Aboriginal people. It develops and maintains valuable working relationships and referral systems with Aboriginal community organizations engaged in addressing fundamental issues of

justice within the Aboriginal community. The Centre provides telephone and drop-in advice and information as well as informal advocacy to the general public. The Centre's staff are also involved in community outreach and public legal education activities.

## Drop-In Centre

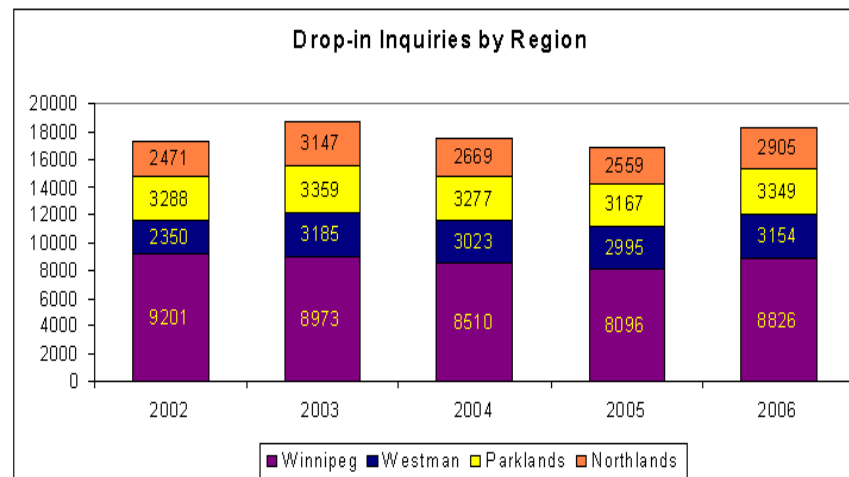
All persons in the City of Winnipeg are seen at the Drop-In Centre located on the 3<sup>rd</sup> floor, 294 Portage Avenue. The Drop-In Centre is open from 1:30 p.m. to 6:00 p.m. on Tuesday, Wednesday and Thursday every week.

The workload is evenly shared among the legal staff of all the Winnipeg offices. The staff providing the service at our Drop-In Centre consists of lawyers, paralegals, articling students and intake officers. The five-person staff complement ensures that there is at least one staff person available to cover every possible need or request as clients attend the Drop-In Centre for a variety of reasons (e.g., for advice, for information, to complete legal aid applications etc).

Advice is available by appointment or over the telephone in all of our community law offices outside of Winnipeg – Brandon, Dauphin, The Pas and Thompson.

## University of Manitoba Law Centre

The Law Centre opens an average of 550 files per year. The vast majority of these files involve defending individuals charged with summary conviction *Criminal Code* offences. The services provided are those that would be provided by counsel acting on behalf of an accused person including negotiations with the Crown, speaking to sentence, and conducting trials. The remainder of the caseload includes the defence of *Highway Traffic Act* offences where conviction would result in licence suspensions, residential tenancy matters, small claims matters such as consumer complaints, and increasingly, representing individuals in disputes with Manitoba Public Insurance.



# 2005/2006 YEAR IN REVIEW

The Law Centre is staffed by second and third year law students who volunteer their time during the academic year. Four students are hired during the summer months to complete ongoing cases and ensure that the services of the Clinic are available to the public during periods when the Faculty of Law is not in session. The students operate under the authority of Section 21 of the *Legal Professions Act* and are registered with the Law Society of Manitoba.



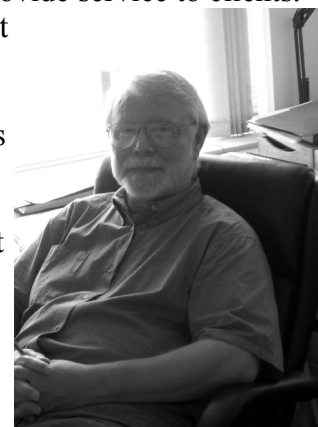
Although students have the primary responsibility for the actual conduct of a file, no major step on a file is taken without the concurrence of a supervisor. Supervision is provided by Professor David Deutscher, the Clinic Director, and staff lawyers from the Criminal Law Office of LAM. In addition, members of faculty and other LAM staff are available to provide advice and information when matters require special expertise.

## LAMAS – Legal Aid Manitoba Application System is Coming

Legal Aid continued throughout 2005 and into 2006 to work with Protegra Technology Group, a Manitoba company, to design, develop and implement an innovative new application, custom built for Legal Aid's unique business process. The "Legal Aid Manitoba Application System" (LAMAS) will integrate into one application the certificate system which has been used to receive applications, issue certificates and pay private bar lawyers since 1987, and the

community law office system used by staff lawyers to track time and appearances on client files. The new application will also integrate data from the accounting system and lawyer calendars.

The process has been challenging but the benefits will include not only a modern integrated application which will allow LAM to track work done and cost expended, but a flexible and useful tool for staff lawyers and support staff with which to provide service to clients. The application is being designed and built using a browser-based user interface and with Open Source tools. At the end of the day LAM will pay no ongoing licence fees for any aspect of the program and will effectively "own" LAMAS outright. There are still some major issues that must be addressed before the application is ready for deployment. LAM staff and Protegra continue to work on LAMAS with a view to implementing it in the next fiscal year.



## New Criminal Court Circuit Added to Duty Counsel Services

LAM provides duty counsel in many criminal and youth courts and some child welfare courts throughout the province. Duty counsel is there to help people who must appear in court but do not have a lawyer acting for them.

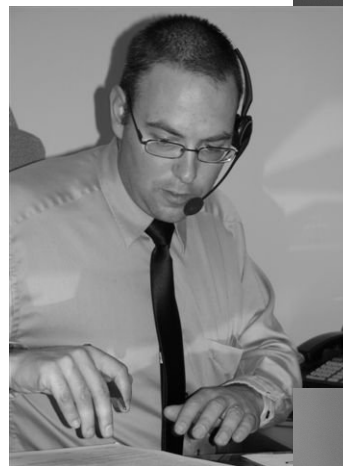
Legal Aid duty counsel is available in 54 Provincial Court locations throughout Manitoba. This includes a new criminal circuit court created in Camperville, Manitoba. The creation of this new circuit is significant as it addresses a concern identified by the Aboriginal Justice Inquiry that this region is underserved by the court system. Prior to the Camperville circuit, Manitobans residing in this region were forced to travel a great distance in order to attend court, while at the same time enduring hazardous travel conditions with poor roads, virtually no public transportation system and sometimes adverse weather conditions.

## Big Case Management Program Proving to be a Success

The Big Case Management Program was introduced in July 2004. This program is designed to manage unusually complex and lengthy cases. As of March 31, 2006 approximately 90 cases have been processed. The aim of the project is to assess the costs of these cases at an early stage to a) provide some predictability to the private bar such that an informed decision can be made on whether to accept a certificate and b) provide cost predictability and management for LAM. The program is proving to be successful and is being continued.

## Drug Treatment Court Project Begins

On January 10, 2006 the Winnipeg Drug Treatment Court sat for the first time. LAM is a major stakeholder in this project which has been in the planning stages for over three and a half years.

This court is a three year federally funded project. The intent is to focus on dealing with the accused person's drug addiction, instead of continuing to incarcerate individuals who commit crimes as a result of or to feed their drug addiction, which in turn will hopefully put a stop to the criminal activity.

Accused persons who elect to participate in the treatment program are closely monitored as they deal with their addiction issues. The treatment program spans approximately one year and upon successful completion, the accused person, who has entered a guilty plea before entering the program, will avoid an incarceratory sentence. LAM provides duty counsel for this court on a weekly basis. In addition, staff lawyers represent individual accused persons in the program. Representatives from LAM continue to be involved as members of the executive committee, the court committee and the evaluation committee.

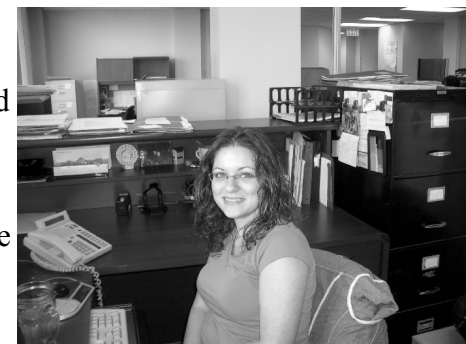
## Collaborative Law Pilot Project Extended

On April 1, 2004 a three year Collaborative Law Project was commenced with Federal funding support. As of March 31, 2006 the project has been extended another year with continued Federal funding. With limited exceptions all family cases where both sides are legally aided are referred to the project. Approximately 26% of family cases met the project criteria.

Cases are distributed to independent community law office staff and private bar lawyers who have received collaborative law training and have opted to join the project.

The project has provided a successful and efficient method of delivering family law services.

Collaborative Law does not use traditional litigation protocols. Cases are resolved without court intervention.



## Investments in Criminal Legal Aid Renewal

For the fiscal period 2003/04 – 2005/06 the Federal, Provincial and Territorial Ministers responsible for Justice agreed to work together on developing a renewal strategy that would ensure the legal needs of economically disadvantaged Canadians are met in a fair and equitable manner.

Over the course of its three year existence, the federal government's Investment Fund has allowed LAM to access over \$3.3M to fund several vital initiatives for the delivery of criminal legal services. More specifically, LAM was able to implement a number of projects which have positively impacted several longstanding unmet needs within our service delivery. Projects implemented over the past years include:

- **Project Management and Coordination** - Hired a policy analyst to undertake a number of core reporting and management activities for the Investment Fund.

- **Aboriginal Services** - Hired a lawyer and legal secretary (in the Aboriginal Law Centre) to provide culturally sensitive criminal legal services.
- **Increase French Language Services** - Contracted a private bar lawyer to provide bilingual duty counsel services in a recently created criminal court located in St. Pierre-Jolys equipping LAM with the ability to meet the standards of “active offer” for legal services in French.
- **Domestic Video Bail Court** - Offset the costs of providing legal support and advice to accused persons held within remand custody for the Domestic Violence Front End Project.
- **Rural Access to Justice** - Hired staff lawyers and support staff in both Thompson and Dauphin, improving access to justice in many northern communities in Manitoba.
- **Rural Travel and Mileage Increments** - Used investment fund resources to increase hourly travel and mileage rates to private bar lawyers taking certificates in northern areas.
- **Communications Officer** - Seconded a staff employee to update and develop new brochures, overhaul the LAM website content, and liaise with the private bar and other key stakeholders.
- **Prison and Parole Law** - Provided legal assistance to inmates dealing with prison and parole issues at Headingley Correctional

Centre and Stony Mountain Institution using staff lawyers and paralegal support.

- **Mental Health Paralegal Project** – Enabled a paralegal to travel to mental health facilities to provide information, take applications, and offer other legal services to clients who have been, or may become involved with the criminal justice system.
- **Enhancement to Brydges On-Call Services** - Used investment fund resources to increase remuneration rates to the private bar providing Brydges on-call service, thereby ensuring round-the-clock coverage.
- **Enhanced Duty Counsel Services** - Hired two junior staff lawyers to provide additional support for the provision of duty counsel services in our Criminal Law Office.
- **Improving LAM Data Management** - Hired an IT specialist to provide assistance developing LAMAS and other Systems' projects to improve our data management.
- **Big Case Management/Complex Cases** - Developed the infrastructure for the Big Case Management project to increase cost predictability of complex cases and ensure fair remuneration for work done by the private bar where cases exceed LAM's tariff.
- **Tariff Committee** - Offset partial costs of the Perozzo Report.

- **Training and Capacity Building** - Developed a series of training sessions (LAMAS, OpenOffice) to improve our capacity in the areas of informatics and legal aid delivery in order to augment service delivery effectiveness and efficiency. Funding was also used to offset the costs in planning and hosting our Staff Seminar.

## Child Protection Full Service Duty Counsel Project Continued

The Child Protection Unit carried out its work under the Full Service Duty Counsel Project from February 2002 to March 31, 2006.

The final evaluation report is due in June 2006, but we already know that the project will continue for another year. An early indicator of the success of the project is that this year we were able to downsize

the Child Protection Unit from 3 lawyers to 2 lawyers, and from 2 paralegals to 1 paralegal, as a result of the effectiveness and efficiencies achieved. The Child Protection Unit continues to contract a social worker who works on site 3 days per week.



## 2005 Staff Seminar a Success

### **The Fallibility of Eyewitness Testimony – A criminal victim's perspective**

Jennifer Thompson was the guest speaker at this year's bi-ennial staff seminar. Jennifer spoke to staff concerning her involvement in the wrongful conviction of Ronald Cotton. In two separate incidents in

July 1984, an assailant had broke into two apartments, severed phone wires, sexually assaulted the female occupant and searched through their belongings, taking money and other items. As one of the victims of the two sexual assaults, Jennifer's identification and testimony was crucial in leading to Ronald Cotton being sentenced to life plus 54 years. However, DNA evidence exonerating Ronald Cotton in 1995. Jennifer provided staff with a remarkably insightful and powerful analysis of the impact of faulty eyewitness testimony and faulty police investigation tactics from the perspective of crime victims themselves.

Staff were particularly moved by Jennifer's presentation. A survey of the event indicated that she was exceptionally well spoken, inspirational and an amazingly powerful and courageous speaker providing “unbelievable insight from two perspectives, how it feels to be a victim of such a crime and how unreliable eyewitness evidence is.”<sup>1</sup>

With society increasingly clamoring for the prosecution of crimes and the punishment of lawbreakers, Jennifer's cautionary tale reinforces LAM staff lawyers' role in ensuring that their clients are treated fairly within the criminal justice system.

## Operational Review Underway

In recent years LAM has been finding it increasingly more difficult to maintain its robust portfolio of core and specialized services while facing budgetary constraints, increasing demand for legal services, increasing case complexity, and diminishing private bar participation. Consequently, the prospect of cutting back on service delivery has become an increasing concern for LAM. Based on this concern and a desire to find financial efficiencies, LAM's Executive Director advised the Board of the need for an operational review of the organization in September 2003.

LAM retained the services of Prairie Research Associates (PRA) to conduct an operational review of the organization to determine how to maintain its core services and maximize its efficiency given current levels of funding. The operational review initiated in April 2005 had three main objectives:

- Produce a financial evaluation of LAM's service delivery model to determine whether LAM administers its resources effectively and efficiently.
- Review LAM's mixed model of service delivery to determine whether this approach is the most effective for delivering services.
- Review LAM's specialized services and compare them to legal aid programs in other Canadian jurisdictions providing similar service.



Based on their preliminary research findings, PRA has identified six main areas within the organization requiring further actions to maximize effectiveness and efficiency within its service delivery:

- Services/Coverage
- Eligibility issues
- Costing legal aid services
- Management issues
- Private Bar/LAM balance
- Governance issues



LAM believes that the report will help renew and strengthen LAM to fulfill its mandate of providing a critical public service to financially eligible Manitobans through comprehensive, quality legal advice and services with solid accountability processes in place.

LAM anticipates PRA's final report in early May 2006.

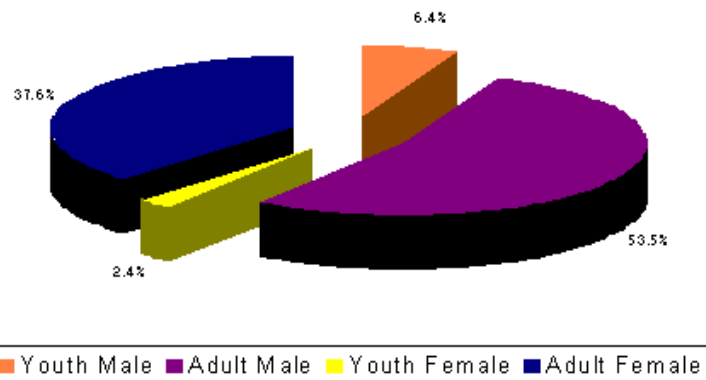

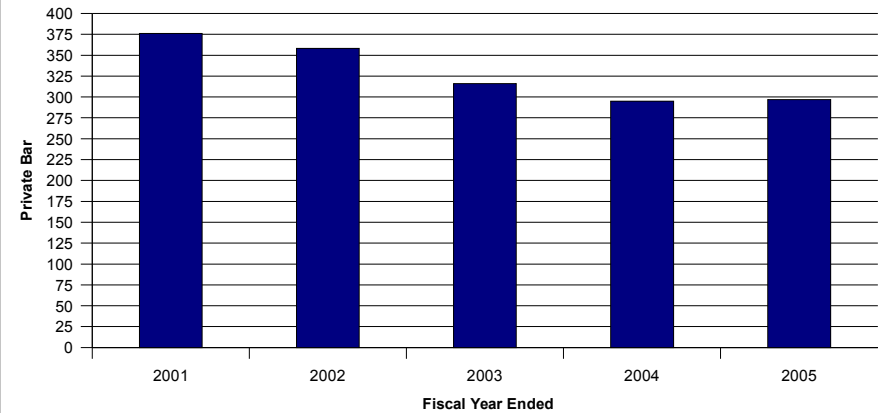

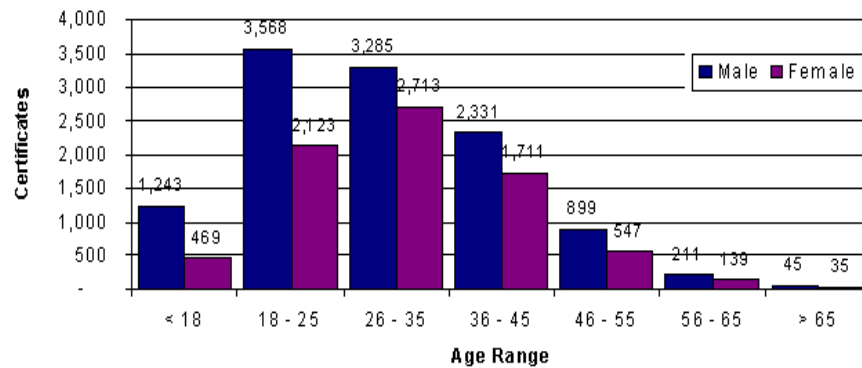
Certificates - Gender Distribution (%)



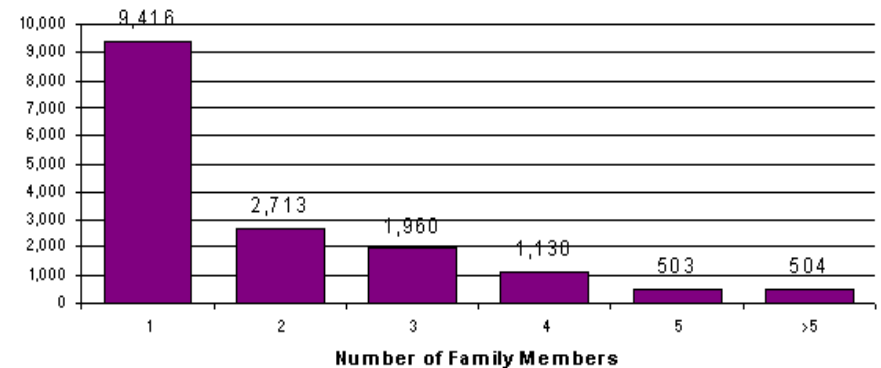
Active Private Bar Members

Certificates by Family Size



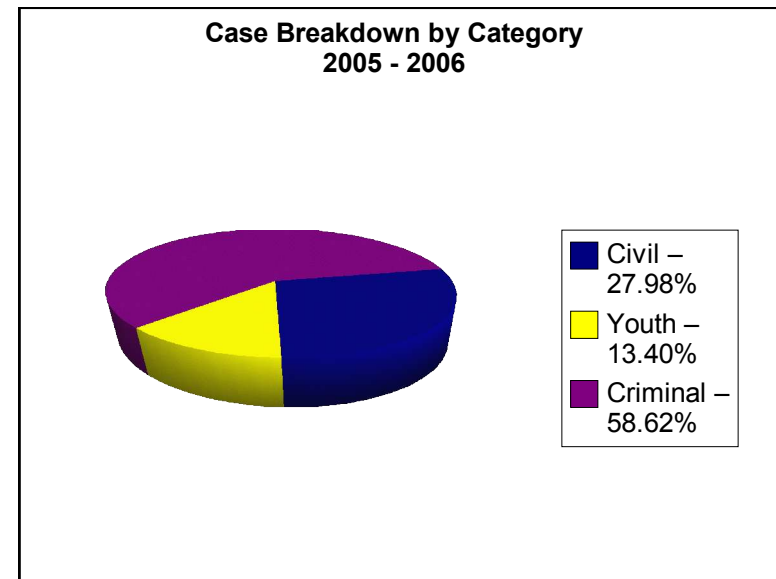
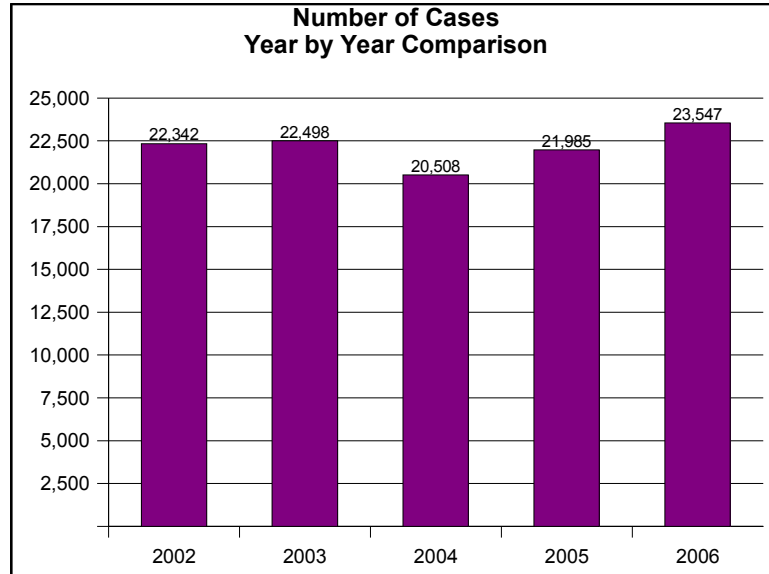




## RESPONSIBILITY FOR FINANCIAL REPORTING



### 1. Nature of the Corporation

Legal Aid Manitoba (the Corporation) was established by an Act of the Legislative Assembly of Manitoba.

The purpose of the Corporation, as set out in the Act, is to service the public interest by:

- a) Providing quality legal advice and representation to eligible low-income individuals;
- b) Administering the delivery of legal aid in a cost-effective and efficient manner; and
- c) Providing advice to the minister on legal aid generally and on the specific legal needs of low income individuals.

The Corporation is economically dependent upon the Province of Manitoba. Other revenue sources include the Manitoba Law Foundation, individual clients, and third party agencies.

### 2. Significant Accounting Policies

#### a) Accounting Basis

The financial statements are prepared in accordance with Canadian generally accepted accounting principles.

#### b) Revenue Recognition

The Corporation follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

#### Recognition of Contributions from Clients

Clients may be required to pay a portion or all of the legal costs incurred on their behalf by Legal Aid Manitoba based on the clients' ability to pay.

i. Agreements to Pay

Clients who are able to pay, sign an agreement to pay for their portion of the applicable legal costs. The amount the client is required to pay is specified on the legal aid certificate. The revenue and receivable are recognized when the certificate is signed.

ii. Expanded Eligibility

Under terms of expanded eligibility, clients are required to pay all of the legal costs and an administration fee of 25% of the Corporation's cost of the case up to a maximum of \$250. The revenue and receivable are recognized based on the date of the lawyer's billing.

iii. Charges on Land

Charges on Land are registered under Section 17 of the Legal Aid Manitoba Act in a Land Titles Office against property owned by clients. The revenue and receivable are recognized at the later of the date the lien is filed or the date of the lawyer's billing. Collection of these accounts in the future is dependent on the client disposing of the property or arranging for payment.

c) Allowance for Doubtful Accounts

The allowances for doubtful accounts are determined annually based on a review of individual accounts. The allowances represent management's best estimate of probable losses on receivables. Where circumstances indicate doubt as to the ultimate collectibility of an account, specific allowances are established for individual accounts. In addition to the allowances identified on an individual account basis, the Corporation establishes a further allowance representing management's best estimate of additional probable losses in the remaining accounts receivable.

d) Capital Assets

Capital Assets are recorded at cost less accumulated amortization. Amortization of capital assets is recorded on a straight-line basis over the estimated useful lives of the capital assets as follows:

- Furniture and office equipment – 10 years
- Computer hardware and software – 4 years
- Leasehold improvements – over the term of the lease

e) Measurement Uncertainty

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingencies at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from these estimates.

f) Pension Plan

Employees of the Corporation are pensionable under the Civil Service Superannuation Act. The Corporation accrues a provision for the liability for the employer's share of employee pension benefits, including future cost of living adjustments, based on actuarial calculations. When actual experience varies from actuarial estimates, the adjustment needed is recognized immediately in net revenue (expense) in the year that the actuarial gain or loss arises.

g) Financial Instruments

The Corporation's financial instruments consist of cash, short-term investments, accounts receivable, accounts payable, and accrued liabilities. Unless otherwise noted, it is management's opinion that the Corporation is not exposed to significant interest, currency or credit risks arising from these financial instruments. The fair value of these financial instruments approximates their carrying values.

#### 7. Long-term Receivable – Severance Benefits

The Province accepted responsibility for the severance benefits accumulated by Legal Aid employees to March 31, 1998. Accordingly, the opening severance pay liability balance as at April 1, 1998 of \$716,166 was completely offset by a receivable from the Province. There are no terms of repayment for the receivable, and the amount will remain fixed at \$716,166.

#### 8. Severance Liability

Effective April 1, 1998, Legal Aid commenced recording the estimated liability for accumulated severance pay benefits for their employees. The amount of this estimated liability is based on actuarial calculations. The periodic actuarial valuation of this liability may determine that an adjustment is needed to the actuarial calculation when actual experience is different from that expected and/or because of changes in actuarial assumptions used. The resulting actuarial gains or losses are recognized immediately in net revenue (expense) in the year that the actuarial gain or loss arises.

An actuarial report was completed for the severance pay liability as at December 31, 2004 by Ellement & Ellement Ltd., Consulting Actuaries. The report provides a formula to update the liability on an annual basis.

Severance pay, at the employee's date of retirement, will be determined using the eligible employee's years of service and based on the calculation as set by the Province of Manitoba. The maximum payout is currently 23 weeks at the employee's weekly salary at the date of retirement. Eligibility will require that the employee has achieved a minimum of nine years of service and that the employee is retiring from the Corporation.

A statutory grant, pursuant to subsection 90(1) of The Legal Profession Act, is received annually from the Manitoba Law Foundation. The Corporation's share under the Act is 50% of the total interest on lawyers' trust accounts as received by the Foundation or a minimum of \$1,007,629, whichever is greater. In the event that interest received by the Foundation in the preceding year, after deduction of the Foundation's operational expenses, is not sufficient to pay the statutory minimum of \$1,007,629 to Legal Aid Manitoba, the Act provides for pro-rata sharing of the net interest.

Other grants from The Manitoba Law Foundation are received pursuant to subsection 90(4) of The Legal Profession Act. These grants are restricted for the Public Interest Law Centre and the University Law Centre. At March 31, 2006, there were no funds remaining from these grants.

#### 14. Provision for Employee Pension Benefits

Pension costs consist of the employer's share of pension benefits paid to retired employees, as well as the increase in the unfunded pension liability during the fiscal year. This liability is determined by an actuarial valuation every three years with the balances for the intervening years being determined by a formula provided by the actuary. The most recent valuation was completed as at December 31, 2004 by Ellement & Ellement Ltd., Consulting Actuaries.

The key actuarial assumptions were a rate of return of 6.50% (2001 – 6.75%), 2.50% inflation (2001 – 2.75%), salary rate increases of 4.25% (2001 – 4.5%) and post retirement indexing at 2/3 of the inflation rate. The projected benefit method was used and the liability has been extrapolated to March 31, 2006 using a formula provided by the actuary.

The Province of Manitoba has accepted responsibility for the unfunded pension liability. Accordingly the provision for employee pension benefits is offset by a receivable from the Province of Manitoba. There are no terms of repayment for this receivable.

#### 15. Restricted Net Assets – Wrongful Conviction Cases

During the fiscal year ended March 31, 2006, the Province of Manitoba approved a reallocation of \$130,000 from Legal Aid Manitoba's unrestricted net assets. This funding is being provided for section 696 applications under the Criminal Code for wrongful conviction appeals on a pilot project basis until March 31, 2007. In the current fiscal year, the Corporation incurred expenses of \$38,689 for private bar fees and disbursements related to wrongful conviction cases.

#### 16. Public Sector Compensation Disclosure

For the purposes of the Public Sector Compensation Disclosure Act, all compensation for employees, Board members and the private bar fees and disbursements from Legal Aid Manitoba is disclosed in a separate statement.

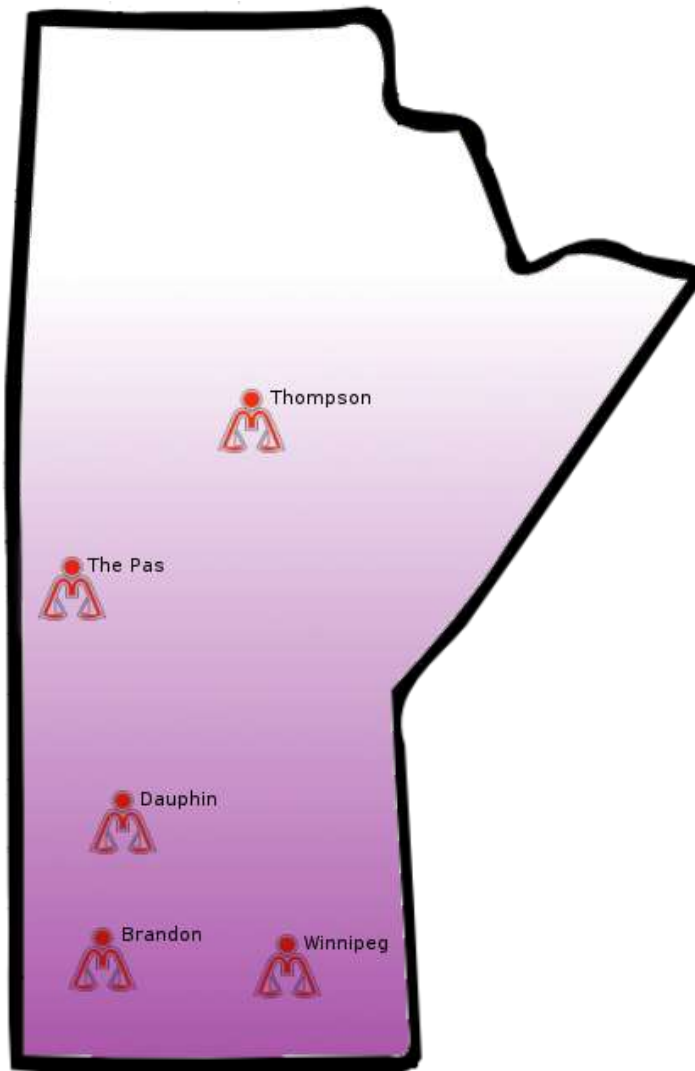
