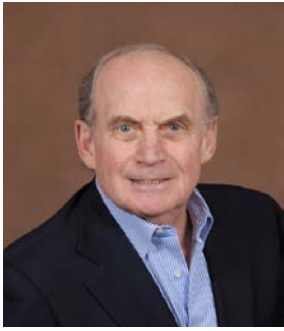


# PUBLIC INTEREST LAW CENTRE ADVISORY COMMITTEE



## **HARVEY SECTER** (Robson Hall Appointee)

Harvey has had distinguished careers in business (Ricki's Stores), law and academics. Harvey served as Dean of the Faculty of Law from 1998 – 2002 is currently in his third term as Chancellor of the University of Winnipeg (2008 - 2019). Harvey currently serves on the boards of Richardson's and FP Newspapers Income Fund.

Harvey holds a Bachelor of Commerce from University of Manitoba.

Subsequently, he earned a Bachelor of Laws degree from the University of Manitoba in 1992 and a Masters of Law from Harvard Law School in 1994. Harvey has served as president of the Jewish Foundation of Manitoba and as a member of the Premier's Economic Advisory Council and the Board of the Health Sciences Centre Foundation.

## **DR. ANNETTE TRIMBEE**

Annette has been President and Vice-Chancellor at The University of Winnipeg since August 1, 2014. Previously, Dr. Trimbee served as Deputy Minister of several departments in the Alberta government, including Finance and Treasury Board, Service Alberta and Advanced Education and Technology. Key accomplishments include Alberta Budget 2012 and 2013, the redesign of Alberta's innovation system and creation of the Alberta Innovates Corporations, bringing Alberta post-secondary institutions together

to plan and collaborate through Campus Alberta, and development of Alberta's Health Policy Framework and Integrated Resource Management Policy Framework.

Annette is of Métis heritage. She holds a BSc from the University of Winnipeg, an MSc from the University of Manitoba and a PhD from McMaster University in Ecology. She was also a Post-Doc Fellow in aquatic ecology at the University of Alberta.

Dr. Trimbee is appointed a member of the Public Interest Law Centre Advisory Committee for a term of 2 years effective December 20, 2018.

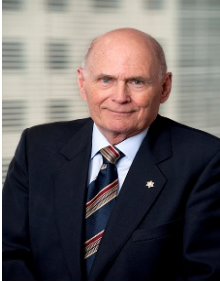


### **JESSICA SAUNDERS**

Jessica was called to the Bar in 2011. She represents Metis Nation and First Nation communities, organizations and child and family services agencies. Jessica practices primarily in the areas of Indigenous law and Child Protection law. Jessica grew up in Cranberry Portage, MB. Her maternal family is from the Metis Nation and Cumberland House Cree Nation and her paternal family is from the Opaskwayak Cree Nation.

Jessica has appeared before the Commission of Inquiry into the Circumstances Surrounding the Death of Phoenix Sinclair, the Public Utilities Board, the Clean Environment Commission and all levels of Court in Manitoba. Jessica was appointed to the Law Society of Manitoba's Social Equity Committee in 2016 and held that position until being appointed to the Law Society of Manitoba's Complaints Investigation Committee in 2018.

### **RICHARD J. SCOTT**

Dick received his Call to the Bar in 1963 and practiced with the firm of Thompson Dorfman Sweatman, as it is now called, until his appointment to the Court of Queen's Bench on June 28, 1985, quickly rising to the position of Associate Chief Justice on October 4, 1985.

On July 31, 1990, Dick was appointed Chief Justice of Manitoba (Chief Justice of the Court of Appeal), a position he held until his retirement in 2013, earning the distinction of being the longest-serving Chief Justice of Manitoba. He served for many years on the board of Winnipeg Harvest.
